PARTNERSHIP WITH VALLEY HEALTH SYSTEM

AFFILIATION AGREEMENT

Touro University Nevada and Valley Health System have entered into an affiliation agreement for eligible* employees. TUN will offer a tuition discount. VHS will provide a tuition remission benefit that will cover up to \$5,250 for full-time employees and \$2,625 for part-time employees, once deemed eligible.

APPLYING FOR BENEFITS:

- Full and part-time VHS employees must contact their HR department to determine if they are eligible* for tuition benefits.
- Once you have confirmed eligibility*, you may apply to the TUN RN to BSN program and indicate your VHS status on the application.



I HAVE MET WITH HR WHAT'S NEXT?

- Complete the TUN online application for the term you would like to start (Summer, Fall, or Spring).
- Submit all necessary documents for admission.
- Upon acceptance and enrollment to the program, maintain eligibility* for benefits. Contact your HR department for more information.

HOW DO I KNOW IF I'M MISSING A PREREQUISITE?

- TUN will inform you if you are missing any coursework that needs to be taken.
- Those who have not taken a course in general chemistry, inorganic chemistry, microbiology or pathophysiology, nursing pathophysiology can be taken online at TUN during the regular program course of study and prior to graduation.
- Nevada and US constitution course must be completed prior to graduation as this is a state-mandated requirement. As part of the tuition discount, TUN will pay 100% for the course. The course is offered for a limited time during the program. You will be notified if and when you need to enroll.

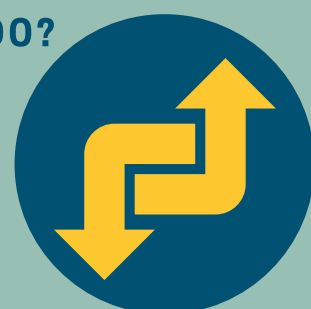


WHAT DOES THE VHS BENEFIT COVER?

- The VHS benefit is valid for tuition and fees for the RN-BSN Program only.
 - **Full-Time Employees:** \$5,250 per calendar year (if approved)
 - **Part-Time Employees:** \$2,625 per calendar year (if approved)
- Students are responsible for their own materials such as computers, books, and supplies.

MY STATUS AT VALLEY HAS CHANGED WHAT SHOULD I DO?

- Please contact your HR department to determine if your eligibility* has been impacted.
- If VHS determines you are ineligible for benefits, you will be responsible for tuition and fees.

I MAY NEED TO WITHDRAW. WILL THIS IMPACT MY BENEFITS?

- Students who withdraw and do not successfully pass the class will not be eligible* for the VHS benefit or TUN discount.
- Students are permitted to take a trimester off; please contact TUN if you would like to request a Leave of Absence or withdraw entirely from the program.

I FAILED A COURSE, HOW IS MY BENEFIT IMPACTED?

- Students who do not successfully pass the class will not be eligible* for the VHS benefit or TUN discount.
- You will have an outstanding balance due immediately.
